There was discussion concerning the possibility of fencing the area by the maintenance building and charging residents to store trailers, campers, etc. This will be discussed further. Council Member Angie Soeder requested that the owner of the small trailer be asked to move it so that it is less visible.

Mayor Williams updated the Council on the status of sealing and striping the streets and that he is in the process of receiving bids.

Mayor Williams also updated the Council on the status of redoing the landscaping at the entrances and that he is getting bids. He will contact Picturescape, the company that did the landscaping at city hall, and request that the owner attend the August council meeting with pictures and sketches of the proposed work.

The owner of the pit bulls gave permission for Animal Control to euthanize them.

The Mayor, Council, and city clerk went into a closed session to discuss possible litigation and personnel matters. Nothing was decided in the session. Council Member Warford made a motion to exit the closed session, seconded by Council Member Whitehouse. Motion carried 5-0.
