COMMON AND SIMPLIFIED ORDINANCES

The summary below contains a partial wording in the complete ordinance.

Mail and Paper boxes: No mailbox and/or paper holder shall be placed on any lot and/or easement unless its design and placement are approved in writing by the City Clerk/Treasurer by the issuance of a no cost permit. City of Heritage Creek mailboxes are black and can be obtained by Duggins Co. 1116 Ulrich Ave. 40219. They also sell the address numbers. (Ordinance 96.01 Mail and Paper Boxes).

Inoperable or Unsafe Vehicles: No inoperative vehicle (incapable of being moved by its own power, for a period of 30 days) shall be parked or kept on any lot, except in a garage. Time period may be extended by the City Clerk/Treasurer upon written application for good cause shown. (Ordinance 72.13 Inoperable or Unsafe Vehicles).

NO Parking Places: Within 10 ft. of a fire hydrant, any place where the vehicle blocks use of a driveway, within 30 ft. of a traffic signal, beacon or sign on the approaching side, within 20 ft. of any intersection or crosswalk, on any sidewalk or where official signs prohibit parking. (Ordinance 72.14 No Parking Places)

STREET Parking: No vehicle to be parked on street EXCEPT on the following city established dates:

- (1) Easter during the hours of 8:00 a.m. through 12:00 a.m. (midnight);
- (2) Mother's Day during the hours of 8:00 a.m. through 12:00 a.m. (midnight);
- (3) Memorial Day during the hours of 8:00 a.m. through 12:00 a.m. (midnight);
- (4) Father's Day during the hours of 8:00 a.m. through 12:00 a.m. (midnight);
- (5) Independence Day during the hours of 8:00 a.m. through 12:00 a.m. (midnight);
- (6) Labor Day during the hours of 8:00 a.m. through 12:00 a.m. (midnight);
- (7) Thanksgiving Day during the hours of 8:00 a.m. through 12:00 a.m. (midnight);
- (8) Christmas Eve during the hours of 12:00 p.m. through 12:00 a.m. (midnight);
- (9) Christmas Day during the hours of 8:00 a.m. through 12:00 a.m. (midnight);
- (10) New Year's Eve during the hours of 4:00 p.m. through 2:00 a.m;
- (11) New Year's Day during the hours of 8:00 a.m. through 12:00 a.m. (midnight);
- (12) Derby Day during the hours of 10:00 a.m. through 10:00 p.m;
- (13) Sundays during the hours of 8:00 a.m. through 10:00 p.m;
- (14) City sponsored events (i.e. city wide yard sales) during the hours of 6:00 a.m. through 6:00 p.m.;
- (15) Unforeseen family crises (crisis events that cause family members to gather on short notice); and
- (16) On street parking will be permitted ONLY on one side of the street. The side with EVEN numbers only when a vehicle may be parked on the curb side of the street where it does not obstruct oncoming traffic. It shall be unlawful to stand or park any vehicle in a street other than parallel with the curb and with the two right wheels of the vehicle within 12 inches of the regularly established curb line.

(Ordinance 72.14 No Parking Spaces)

Front/Side Yard Parking: NO trailer, semi tractor trailer, commercial vehicle, camper, trailer, camping vehicle or boat shall be parked or kept on any lot nearer to the street than the front building line of the house constructed on the lot. NO parking in the front yard or street side yard shall be permitted. (Ordinance 72.06 Front Yard Parking).

Trash Cans: Containers shall be stored in the rear yards of homes. No burning of trash and/or garbage on any lot. (Ordinance 50.01).

Solicitors: A license shall be obtained before engaging in activity within the City of Heritage Creek. All applicants can file an application with the City Clerk or Mayor. (Ordinance 111.02 License Requirement).

Mowing Grass/Weeds

- (A) It shall be the duty of each lot owner to keep grass on the property cut, to keep the lot free from weeds and trash, and to keep the lot otherwise neat and attractive in appearance.
- (B) Grass must be maintained so as not to exceed 12 inches in height.
- (C) Should any owner fail to do so, the city and/or its agent may take action as deemed appropriate, including mowing, in order to make the lot neat and attractive, and the owner shall immediately upon demand, reimburse the city and/or its agent or other performing party for all expenses, together with allowable statutory interest. Any person, firm or corporation violating any section of this chapter not otherwise listed, shall be charged a civil penalty of not less than \$5 and not more than \$50 for each offense. Each day a violation of this chapter occurs is a separate.
