## ORDINANCE NO. \_\_7\_\_ - 2021\_

AN ORDINANCE PROVIDING FOR THE HEALTH AND WELFARE OF RESIDENTS AND ANIMALS WITHIN THE MUNICIPAL BOUNDARIES OF THE CITY OF HERITAGE CREEK, JEFFERSON COUNTY, KENTUCKY.

WHEREAS, the City of Heritage Creek has previously established Residential Development and Maintenance Standards in Ordinance No. 01-2000 which addresses the raising, breeding and keeping of animals on lots within the City of Heritage Creek, and

WHEREAS, the City Council of the City of Heritage Creek has become aware of unhealthy and unsanitary practices that have occurred within the municipal boundaries of the City of Heritage Creek, and

WHEREAS, the City of Heritage Creek believes these unhealthy and unsanitary practices endanger the health of city residents and other animals that are maintained in the City, now therefore

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF HERITAGE CREEK, JEFFERSON COUNTY, KENTUCKY as follows:

SECTION ONE: No person shall mutilate any animal whether dead or alive. This provision does not apply to accepted livestock practices concerning humane slaughter at licensed stockyards, slaughterhouses and meat packing establishments. Further, this section shall not apply to the processing of fish or wildlife taken through legal hunting and fishing methods.

SECTION TWO: It shall be unlawful for any person to kill livestock for the purpose of human or animal consumption on any residential lot or parcel of land.

SECTION THREE: Any person, firm or corporation violating any paragraph of this Ordinance shall be charged a civil penalty of not less than Fifty Dollars (\$50.00) and nor more than Two Hundred & Fifty Dollars (\$250.00) for each offense.

SECTION FOUR: Each day a violation of this Ordinance occurs is a separate offense.

SECTION FIVE: This Ordinance shall be published according to law.

SECTION SIX: All ordinances or parts of ordinances in conflict with this Ordinance or any part of this Ordinance are repealed.

SECTION SEVEN: Should any section, clause, line, paragraph or part of this Ordinance be held unconstitutional or invalid for any reason, the same shall not affect the remainder of the Ordinance.
