### Meeting Minutes

At the beginning of the meeting, Cliff Ashbourne and Michael Gross from LDG Development spoke about the proposed development at 8300 Cooper Chapel Road. Access points were discussed, and they asked for ideas from the council members. They offered to plant trees and match fences behind houses. There was much discussion concerning street closings and traffic.

The mayor's assistant gave the Fischer Homes update. There was one August closing for a total of 21 closings to date. There are currently 31 available lots, 8 under construction, and 2 market homes available.




## Mayor Comments
