## ORDINANCE NO. 01-2021

AN ORDINANCE CLOSING/ABANDONING A PORTION OF FANTASY TRAIL AS A PUBLIC WAY MAINTAINED BY THE CITY OF HERITAGE CREEK.

WHEREAS, the City of Heritage Creek thru annexation may have become responsible to maintain a portion of a public way known as Fantasy Trail, and

WHEREAS, a portion of this public way is no longer needed as a portion of the municipal roadway system requiring it to be municipally maintained, and

WHEREAS, KRS 82.405 specifies the procedure which must be complied with to legally close/abandon this portion of Fantasy Trail, now, therefore,

The City Council of the City of Heritage Creek, Jefferson County, Kentucky, does hereby ordain as follows:

## SECTION ONE: LEGISLATIVE FINDINGS OF FACT.

- a) The property owners in or abutting this portion of Fantasy Trail, are:
  - i) Brian W. Cushman Deed Book 10342 Page 373
  - ii) Marcia Bauer Cotton Deed Book 9153 Page 156
- b) Written notice was given to each of the owners of record, in or abutting the portion of Fantasy Trail to be close/abandoned by mail on February 27, 2021.
- c) All property owners in or abutting the portion of Fantasy Trail to be closed/abandoned have given written notarized consent to this closure/abandonment.

## SECTION TWO: Description.

The portion of Fantasy Trail to be closed/abandoned by the City of Heritage Creek is described as follows:

Beginning at an iron pin, said pin being located in the northeast corner of Lot 123, Heritage Creek West Subdivision, Section 2 (Plat Book 51 Page 24), thence S 84° 20' 04" E 50.00' to an iron pin in the northwest corner of Lot 122 Heritage Creek West Subdivision Section 2 (Plat Book 51 Page 24), thence with the west property line of Lot 122 Heritage Creek West Subdivision, Section 2, S 05' 51' 21" W 126.71' to a point, N 84° 20' 04" W 50.00' to a point in the east property line of Lot 123, Heritage Creek West Subdivision Section 2 (Plat Book 51 Page 24), thence with

the east property line of Lot 123 Heritage Creek West Subdivision, Section 2 (Plat Book 51 Page 24) N 05' 51' 21" E 126.71' to the point of beginning.

SECTION THREE: This Ordinance shall be published according to law and a certified copy shall be filed with the office of the Jefferson County Court Clerk.

SECTION FOUR: This Ordinance is enacted pursuant to KRS 82.405 et seq.

SECTION FIVE: Any ordinances or part of ordinances in conflict with this Ordinance or any part of this Ordinance are hereby repealed.

SECTION SIX: Should any section, clause, line, paragraph, or part of this Ordinance be held unconstitutional or invalid for any reason, the same shall not affect the remainder of this Ordinance.
